The feeling of repose, free from time, that its unmistakable melodic melismatic line teaches us to "live" (illuminating a farewell without anguish, if not a promise of eternity), actually contrasts with the message that accompanies UCILeR's new beginning ... and with itsimplacable counting down (as if this message were proclaimed by the strident loudspeakers of a Brave New World).

As UCILeR is one of the three hundred and twelve R&D units to be evaluated in 2023/2024, the first stage of this process is actually already there: I am considering the registration procedure which triggers this evaluation and which has as insurmountable limits September 14th and October 10th. With regard to this evaluation, it is important not to forget that it focuses on the activities carried out between January 1, 2018 and August 31, 2023... but also on the "objectives, strategy, activity plan and organization" that (until January 2024) we will be able to programme for the 2025-2029 cycle... Is this compatible with the miraculous suspension of time (free of deadlines) that we considered supra? Certainly not, which means that ourSeptember will inevitably be another one...

## Provisional results: FCT awards 7 PhD scholarships to students hosted by the UCILeR

On 31 July, the Fundação para a Ciência e a Tecnologia (FCT) published the provisional results of the 2023 Call for PhD Studentships in all Scientific Domains. In the scientific panel for law, 24 research grants were recommended for funding, seven of which were awarded to students whose host research centre is the UCILeR.





## **Funding applications**

The project **EU-CIEMBLY:** Creating an Inclusive European Citizens' Assembly has been selected for funding under the topic Intersectionality and equality in deliberative and participatory democratic spaces TOPIC ID: HORIZON-CL2-2023-DEMOCRACY-01-07 in Cluster 2 of Horizon Europe. EU – CIEMBLY addresses the need for the introduction of new forms of citizens' participation and deliberation in EU political life and, particularly, an EU Citizens' Assembly whose design and implementation fully addresses issues of intersectionality, inclusiveness, and equality. The project will be coordinated by the UCILeR, led by Dulce Lopes.

The **Policies, Law and Services for Migrants** project, submitted to the Fulbright Specialist programme, has been approved. The specialist, Sharvari Karandikar, a professor at the College of Social Work at the Ohio State University (US) will collaborate with the UCILeR for 16 days starting in October, organising workshops on the theme of migration and designing a research project focusing on the refugee and migrant population in Portugal. The Fulbright specialist will be accompanied by Ana Margarida Gaudêncio and Marta Graça.

The CHANGER - Challenges and Innovative Changes in Research Ethics Reviews was approved in the Horizon Europe Programme (HORIZON-WIDERA-2023-ERA-01-12). This project is coordinated by the National Center for Scientific Research "Demokritos, Greece, and it aims to promote changes in ethical reviews in research projects that strengthen researchers' capacities to incorporate ethical judgments in project design and implementation, and support ethics committees in addressing new challenges posed by new technologies and new research practices. The participation of the UCILeR is led by André Dias Pereira.

The ELHEC-RA - Environmental Literacy in Higher Education Context for Preventing Radicalization in Climate Activism was approved in the Erasmus+ Programme. The project is coordinated by the University of Siena (Italy) and it aims to prevent radicalisation processes within the contexts of activism related to environmental sustainability issues and the fight against climate change by enhancing the environmental literacy of university students. The participation of the UCILeR is led by Alexandra Aragão.


i.COST Actions






## ii.Call for Papers: Undecidabilities and Law

## I - INTERFACE SEGURA

Coordinator at the IJ/FDUC: Fernanda Paula de Oliveira

Purpose: 1) Characterisation of the territory, with identification and assessment of the risk in terms of the occurrence of fires in the Urban-Forest Interface (UFI), based on case studies; Characterisation of the surroundings and the built environment and their vulnerability; 2) Application of the principles of Fire Safety Engineering in UFI zones considering forest fire scenarios; Mitigation of ignitions in the built environment by analysing and characterising the behaviour in terms of reaction and resistance to fire of construction products; Development of technical recommendations for the protection of buildings and relevant technical infrastructures; 3) Use of predictive computational tools; Modelling the spread of forest fires; Computational Fluid Dynamics modelling of IUF forest fires and their impacts on the built environment; and 4) Education/awareness-raising among the population; Development of more resilient communities.
