### I. Latest UCILeR events



**Hague Rules: Anniversary Celebrations Closing** 

The International Congress marking the closing of the celebrations for the 100th anniversary of the Hague Rules, an event dedicated to transport law and international contracting, was held on 8 November 2024.

Throughout the year, a series of initiatives, including webinars, congresses and a special publication, were organised to celebrate this milestone. The aim of these activities was to promote in-depth reflection on the Hague Rules and their application, as well as to debate the future challenges of maritime transport, such as safety issues, environmental concerns, and the development of autonomous shipping, among others. This centenary was also an occasion to honour Portugal's rich maritime tradition.

II Legal SciComm Conference: Research and Practices

The 2nd Legal SciComm Conference, an event focused on legal communication, was held on 12 November 2024 at Colégio da Trindade. This year, under the theme 'Research and Practice', the conference brought together researchers, academics, students, and legal and linguistic professionals to debate innovative strategies for simplifying and clarifying legal language for lay audiences. The programme included lectures, a practical workshop, and round tables addressing challenges and advances in the practice of communicating legal topics to the public and the scientific community, promoting an inclusive dialogue between law, science, and society. It also included the presentation of research and experience reports resulting from the call for papers.



### 1st Luso-Brazilian Seminar on Reproductive Rights

The 1st Luso-Brazilian Seminar on Reproductive Rights, organised by researchers André Pereira and Raíssa Lima e Salvador, was held at Colégio da Trindade on 18 and 19 November 2024.

The aim of this seminar was to strengthen the protection of reproductive and sexual human rights, both by sharing experiences and good practices from Brazil and Portugal and by strengthening joint strategies to ensure bodily autonomy, equitable access to reproductive health and the promotion of effective public policies for the most vulnerable human groups.

### Law and Time: X Meeting of doctoral researchers

On 25 November 2024, the event 'Law and Time: X Meeting of doctoral researchers' was held at Colégio da Trindade.

This event featured two conferences, one dedicated to Justice and wisdom: ethical and intellectual virtues and the realisation of law, given by Nuno M Santos Coelho (USP) and the other entitled Phronēsis as openness to the situation: existential heritage and appropriation. The special session was attended by António Sá da Silva, Ana Elisabete Ferreira and Bruno Moura.

Democracy: Futures, pasts and memories to come - The Carnation Revolution and the Law

The meeting 'Democracy: Futures, Pasts, and Memories to Come - The Carnation Revolution and the Law' was held on 27 November 2024. This meeting is part of a cycle of conferences that began in 2023, to link the 50th anniversary of the Carnation Revolution with the chronology of the revolution of 1383-1385. The aim was to debate the meaning of the revolutionary phenomenon and its relationship with the law, taking into account the Portuguese experience of the events of April 1974 and all their legal consequences.



### Sustainability: Achievements and Challenges

The event Sustainability: Achievements and Challenges was held on 29 November 2024, coordinated by J.M. Coutinho de Abreu and organised by Alexandre Soveral Martins, Carolina Cunha and João Pedro Rodrigues.

The event covered a range of topics that have been debated and/or changes made to the respective legal framework, with the main theme being sustainability, both from an environmental and from an economic and social point of view. The role of companies was highlighted, not only because they are responsible for a large part of the decarbonisation effort, but also because they ensure economic development.

The Climate Justice Activism Conference: is it possible to change the world without breaking the rules? was held on 11 December 2024. This conference was organised as part of the ELCRA Project, in which the University of Coimbra participates as a partner, through the UCILeR. The Conference aimed to present the main results of the research carried out so far and brought together researchers from partner universities, students, and environmental activists to discuss issues relating to climate justice movements.

The evaluation and planning meetings for the project's next actions with all the partners took place on 10 and 12 December in the FDUC history room.

ELCRA is a project funded by the ERASMUS+ programme, which aims to understand the attitudes and opinions of university students on issues related to environmental sustainability and the fight against climate change, studying the phenomenon of youth participation in environmental activism movements as a preventative measure against radicalisation phenomena that can lead to violence.



Final results 2024: FCT awards 7 PhD scholarships to students hosted by the UCILeR

On 5 November, the Fundação para a Ciência e a Tecnologia (FCT) published the final results of the 2024 Call for PhD Studentships in all Scientific Domains. In the scientific panel for law, 21 research grants were recommended for funding, seven of which were awarded to students whose host research centre is the UCILeR.

Students Ana Carolina Rodrigues, João Narciso, Luiza Franco, Pedro Domingos, Pedro Pizzotti, Stéfani Reimann Patz and Túlio de Aguiar were recommended for funding for their research.



### Navigating Abortion Laws after the end of Roe v. Wade

On the morning of 26 November, several UCILeR researchers met with Professor Robin Wilson - University of Illinois College of Law, co-director and founder of the Family Law and Policy Programme and co-director of the Epstein Health Law and Policy Programme, specialising in family law and health law - debating the issue of voluntary termination of pregnancy, a topical issue in Portugal and the USA. In the light of civil law and common law perspectives, repercussions at a personal, family, social and political level were analysed, verifying vulnerability as an intrinsic feature of the human condition and exploring the most appropriate and constructive responses that the Law can offer.



Plan D promotes art and science communication workshop

On 16 December 2024, the Plano D - Diálogos com o Direito project held a workshop at the Colégio da Trindade dedicated to science communication, bringing together researchers from law, other scientific areas (biology, psychology, among others) and members of civil society linked to communication and tourism to reflect on visual and artistic forms that establish a connection between different scientific areas, art and current social problems. This workshop was led by architects and DARQ lecturers Carlos Antunes and Désirée Pedro, and painter Juan Domingues.

### Plan D - Dialogues with the Law launches promotional video on social networks

Plan D - Dialogues with the Law has already released a promotional video on the official YouTube channel of the UCILeR. The first episode, climate action, is scheduled to premiere in January 2025. This initiative, promoted by the UCILeR in partnership with the Instituto Superior Miguel Torga (ISMT), aims to highlight the relevance and cross-cutting nature of law in all areas of human life. Plan D explores the interactions between law and other areas of scientific knowledge and society, which are fundamental to tackling current challenges.

Over the course of the series, 8 conversations were recorded with researchers from the UCILeR, other UC research centres/faculties or the ISMT, and representatives of civil society, NGOs or companies. The debates include topics such as climate action, virtual currencies, mental health, housing challenges, armed conflicts and war, drug policies, gender identity and artificial intelligence. These conversations were held and filmed in various spaces at the UC, depending on the theme.

This initiative was one of the 10 activities supported by the Initiative for the Promotion of Scientific Culture.
