

The Portuguese version of the comparative study on non-custodial sentences and measures in the Member States of the European Union (EU), entitled "Non-custodial Sanctions and Measures in the Member States of the European Union: Comparative Report", has recently been published.

The comparative study is the result of the project "Promoting non-discriminatory alternatives to imprisonment across Europe" (PRI ALT EUR), coordinated by Penal Reform International (PRI), with the University of Coimbra (UC) and the Hungarian Helsinki Committee (HHC) as partners, and funded by the European Union (JUST-JCOO-AG-2020). This project aimed to understand and promote the use of alternatives to prison sentences in the European Union, with a special focus on the most vulnerable people and the impact of the pandemic on the application and execution of these sentences.




### i.Call for the National Study of Roma Communities




### ii.Call for Papers: Undecidabilities and Law

### I - EVACUAR FLORESTA

Coordinator at the IJ/FDUC: Fernanda Paula de Oliveira

Objectives: 1) To characterise the territory from the point of view of demographics, actual transport networks and current territorial planning/ordering, factors that can lead to significant problems in evacuation during a high hazard fire event; 2) To study the impact of three scenarios as emergency plans for communities: evacuation, shelter in place and/or shelter at home (or partial combinations), providing guidance on the circumstances that favour evacuation and those that do not; 3) Predicting the behaviour and profile of the individuals involved; 4) Estimating the risk of evacuation; 5) Determining support vehicles, timetables and routes required under uncertainties in the population of evacuees, time available and the spread of the fire; 6) Prioritising awareness and educating the population on this issue (using dissemination actions), promoting the resilience of populations.



### II - MIGRATION, HUMAN RIGHTS AND CITIZENSHIP

Coordinator at the IJ/FDUC: Ana Gaudêncio

Purpose: Research into the impact of migration in different contexts of citizenship in today's complex and heterogeneous societies, thus presenting itself as one of the possible measures to be implemented in pursuit of the millennium Sustainable Development Goals (SDGs) proposed by the UN.
