## INTERNATIONAL CONFERENCE “CURRENT CHALLENGES AND LEGAL RESPONSES IN HEALTH”

The event, organized by the Center for Biomedical Law at the University of Coimbra Law School in partnership with the UCILeR, was held at the College of Trindade. It hosted two panels: “Controversial issues in Medical Law” and “The health context and resource management”. The scientific committee was composed of Professors André Dias Pereira and Federico Arnau Moya.





# I. Internal life of the UCILeR

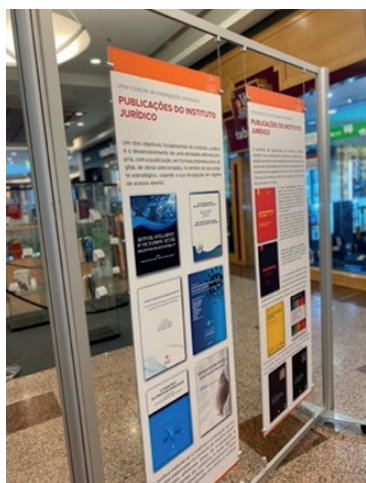
## i. Research Talks at the College of Trindade



Two sessions of the program “Research Talks at the College of Trindade” were held in July. The program, which started in 2021, aims to encourage the debate and exchange of ideas on national and international science policies and funding. The theme “*Law Research in Artificial Intelligence*” was debated on 19th and the topic “*Project Funding 2023 in Cluster 2 of Horizon Europe - Analysis of Opportunities for UCILeR*” was addressed on 23th. The events were attended by UCILeR researchers and PhD students.

## ii. Exhibition “What does UC research?” at Coimbra Shopping

The UCILeR participated in the cycle of exhibitions promoted by the Institute of Interdisciplinary Research of the University of Coimbra between July 8th-21st, at Coimbra Shopping. According to Ana Margarida Simões Gaudêncio, member of the UCILeR Board, the UCILeR's participation shows the “ongoing scientific activity, developed in projects, publications and scientific meetings, in the different thematic strands of its strategic project, thus establishing a link with the community, disseminating legal solutions to practical problems arising from the main social challenges of our time”.



### iii. Summer with Science



The UCILeR project funded by the FCT, offers 8 scientific initiation grants (€486.12) for undergraduate or master's degree students in Law, Political Science, Sociology, Communication Sciences or other Social Sciences and Humanities. The project, to be carried out in September 2022, aims contribute to the promotion of scientific and technological culture and the dissemination of scientific and technical knowledge among higher education students.

### iv. Participation in the project "EVACUAR FLORESTA - Decisions and Evacuation Plans in Forest Fire Scenarios"



The UCILeR participates in the project "EVACUAR FLORESTA - Decisions and Evacuation Plans in Forest Fire Scenarios" led by the Faculty of Science and Technology, University of Coimbra (FCTUC) with the partnership of the National School of Firefighters (ENB) and the Centre for Forestry Innovation and Skills (SERQ). The project's main goal is to create a decision support system for the protection of the community at risk in rural fires.

### v. MediMARE project at the Oceans Conference Lisbon

The UCILeR presented the MediMARE project at the Lisbon Oceans Conference. The event took place between June 27th and July 1st with participation of about 7000 people, including heads of state, scientists, environmentalists and NGOs. The MediMARE project, led by the UCILeR in partnership with the NOVA School of Science and Technology, the Polytechnic Institute of Lisbon and the NTNU Samfunnsforskning, aims to give visibility to mediation as a peacemaking tool and to discuss best practices and skills that can contribute to the training of mediators specializing in maritime disputes who may act internationally.

## vi. Approved projects

### a) ALICE - Air pollution: a stressor for environmental justice

The project ALICE - Air pollution: a stressor for environmental justice was approved for funding by FCT under the Call for R&D Projects in all Scientific Domains - 2022. The project is led by the University of Aveiro and has the participation of the UCILeR, with Dr. Alexandra Aragão as CO-IR of the project.



### b) Promotion of Scientific Culture 2022 - University of Coimbra

Two projects of the UCILeR, among other ten projects, were selected under the initiative “Promotion of Scientific Culture 2022”, organized by the University of Coimbra.

1. ***Coffee with debate. Artificial Intelligence and Responsibility: current legal and technical panorama (in partnership with CISUC and Computer Engineering Department).***

This is a multidisciplinary program aimed at debating the current landscape of public regulation of artificial intelligence, as well as its future prospects for development and associated issues integrating the different stakeholders involved. The topic “Responsibility and good practices in the development and governance of AI systems” will be discussed among developers of AI systems and operators of law. The UCILeR team includes José Ricardo Marcondes, Susana Aires de Sousa, and Fernando Borges.

2. ***The World Day of Cities: Right to Citizenship and Culture (in partnership with researchers from the Faculty of Sciences and Technology, College of Arts and CES).***

The event intends to create an annual activity which will shed light on the University of Coimbra and disseminate the scientific knowledge produced on urban issues. The bridge among the academic community and civil society will be built by the UCILeR Law Research. The project involves an art contest focused on the city and the topics studied by UCILeR. The UCILeR team includes Cristina Perestrelo and Professors Fernanda Paula Oliveira and Fernando Borges.

## I. Call for Scholarships and Funding

### i. 2<sup>nd</sup> Edition of the Maria de Sousa PhD Research Scholarship Competition

Two years after the death of this distinguished Portuguese researcher, the FCT announced the 2nd edition of the competition in collaboration with the AICIB (Agency for Clinical Research and Biomedical Innovation). The contest will award 50 research grants in epidemiology and virology. The goal is to encourage the acquisition of knowledge to enable the creation of competencies for responses and efficient prevention to virological phenomena, or in other words pandemics, with focus on better health care and effective support for the population. Funds must be spent entirely on research and the remainder unspent must be returned to the Trust at the research conclusion. 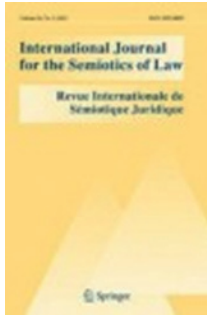

Circumstances permitting, all accepted papers will be presented at a workshop at the Max Planck Institute for Comparative and International Private Law in Hamburg on a date TBC in May or June 2023. Bilateral initiatives may take place in Portugal and/or Norway or in any other territory of the European Economic Area that, from a bilateral perspective,

may be of interest to Portuguese and Norwegian partners. Examples of potentially supportable activities are: matchmaking events; technical cooperation and exchange; internships; training and intensive courses; workshops and seminars; study visits; studies and publications; campaigns, exhibitions and advertising material. The third phase of the program is accepting applications up until November 25, 2022. ### ii. INTERREG V-A SPAIN-PORTUGAL: Cooperation Program (POCTEP) 2014-2020 (6th call for projects: selection for capitalization actions for approved projects)



The objective of this call - open to all investment priorities of axes 1, 2, 3 and 4 of the POCTEP 2014-2020 - is to build on the successes of the program and capitalize on the results of completed projects by increasing their cross-border impact, besides promoting the approach of cooperation actions according to the themes provided for in POCTEP 2021-2027.

It means that the program seeks the implementation of new actions from the results of one or more good practices of past projects. This must be grounded in the transfer of results to other areas, improving the results themselves, and diversification of products, among other similar actions. Beneficiaries must be entities that hold approved projects in accordance with the requirements. The deadline takes into account the calendar for the submission of proposals, and the decision making by the Territorial Committees and the Management Committee will be made according to the following schedule: (1) October 2022: for proposals submitted from 01/06/2022 to 30/09/2022; and (2) February 2023: for proposals submitted from 16/10/2022 to 16/01/2023. The minimum budget is €50,000.

## IV. Calls for awards and grants

### i. Francisco Manuel dos Santos Foundation Study Program



Submissions will be received during the term of the current Studies Program (2021-2023). The priority themes to be explored in the projects awarded by the Foundation are defined beforehand by its Governing Bodies and published in the three-year Research Program, including: issues related to digital, security, climate change, crisis and opportunity. As a rule, authors of the Foundation's studies are academics linked to national and international universities and research centers, selected through a public and transparent process, in order to ensure the rigor and independence of the research produced.
