### COFFEE WITH DEBATE. ARTIFICIAL INTELLIGENCE AND RESPONSIBILITY: CURRENT LEGAL AND TECHNICAL PANORAMA

The first session of "Coffee with Debate: Artificial Intelligence and Responsibility: current legal and technical panorama" took place on September 21, 2022 in an informal atmosphere. The audience was made up of lawyers and law students from different study cycles. Audience participation was encouraged. A coffee played a key role in bringing people together and encouraging interactions



### INTERNATIONAL CONGRESS "THE REVOLUTION OF 1820 AND THE CONSTITUTION OF 1822: 200 YEARS OF LIBERALISM AND CONSTITUTIONALISM IN PORTUGAL"

The event held at Colégio da Trindade between September 22 and 23, 2022 promoted reflections in the light of a triple perspective - legal, historical and philosophical - on one of the most significant milestones of national history. The programme included topics such as the 1820 Revolution and legal thought; the 1820 Revolution and the teaching of law at the University of Coimbra; Brazil's participation in the first Constitutional Courts; the 1820 Revolution and Portuguese monarchical constitutionalism; Constitutionalism and the 1822 Constitution; Portuguese constitutionalism and other constitutional movements; and revolution and counter-revolution.



### COFFEE WITH DEBATE: ARTIFICIAL INTELLIGENCE AND RESPONSIBILITY: FINAL - FINTECH AND ARTIFICIAL INTELLIGENCE IN FINANCE

The multidisciplinary event took place on September 28, 2022 at the Pedro Nunes Institute (IPN), with the title "FinAI - Fintech and Artificial Intelligence in Finance" developed by the Centre for Informatics and Systems of the University of Coimbra (CISUC).



### WORLD CITIES DAY: CITIZENSHIP LAW AND CULTURE (IN PARTNERSHIP WITH THE FACULTY OF SCIENCE AND TECHNOLOGY, COLLEGE OF ARTS AND CES).)

The Project "World Cities Day - Citizenship Law and Culture", promoted by UCILeR, was formally presented at the Colégio da Trindade, on September 30, 2022. The audience included the project team, teachers from the 3rd cycle of basic education and high school and Professor José Carlos Mota (Department of Social, Political and Territorial Sciences of the University of Aveiro). The project involves the participation of schools in an art contest that focuses on a reflection over the city from the perspective of the topics researched at the UC. The UCILeR team comprises Cristina Perestrelo and Professors Fernanda Paula Oliveira and Fernando Borges.





### **CHALLENGES OF THE FISCAL STATE**

The event was held on September 29 and 30 at the Colégio da Trindade. Speakers made presentations around three central topics: (1) New and revisiting trends in the fundamental principles of tax law, (2) Challenges to the legal tax relationship, and (3) Challenges to tax justice. The organizing committee involved Professors José Casalta Nabais, Jónatas Machado, Matilde Lavouras, João Pedro Rodrigues, as well as Marta Costa Santos, Natália Moreno and Joana Neto.



### THE EVOLUTION OF POST-DEMOCRACY

The workshop occurred on October 20-21, featuring invited speakers and presentations from those who participated in the call for papers. The event established an interdisciplinary debate - covering political philosophy, political theory, philosophy of law, legal dogmatics, philosophy, sociology, history, theory of culture, and other subjects - about the current state and future development of theories of democracy and democratic regimes. The organizing committee comprised Professors Ana Margarida Gaudêncio (UCILeR), Luís Meneses do Vale (UCILeR), and Veith Selk (Institute of Political Science, Technical University of Darmstadt, Germany).



### EDUCATION, HUMAN RIGHTS AND CITIZENSHIP: PILLARS FOR OUR COMMON AGENDA

The online debate was held on October 10th with the objective of promoting a new model of interdisciplinary academic interaction, contributing to the improvement of the design, organization and usefulness of interdisciplinary scientific events. The "inverted debate" model began with the intervention of the discussants, who identified their area of academic research. Then, the interventions and mutual reactions from the speakers followed in turn, as well as a brief Q&A session. Finally, participants shared opinions, suggestions for improvement, and other contributions. This reinforced the richness of academic interactions, which strengthens the potential of interdisciplinary scientific debates on broad and complex topics for the most direct audience - current academic researchers - and indirectly, for society as a whole.

### i. 2022 Summer with Science at UCILeR: Roundtable on academic career



During October 11-15, the 2<sup>nd</sup> Model ECI took place at the University of Göttingen. The project aims to contribute to the development of hard and soft skills related to the higher education systems in the European Union. During this week, tutors, professors and participants from the universities

of Coimbra, Iasi, Vigo and Göttingen worked together to compose joint initiatives aimed at strengthening European democratic systems. This was done by simulating the process of submitting a European Citizens' Initiative, in a public hearing with the European Parliament and meeting with the European Commission.

### vii. Participation in "Futures: Forest Technological Show"

The researchers Fernando Borges and Karoline Vitali participated in the "Futures: Technological Forest Show", representing the UCILeR, on October 19, in Cantanhede. Currently, the UCILeR is developing 4 projects involving this topic: House Refuge, Safe Interface, Evacuate Forest and FirEUrisk. Under the theme "The Futures of Forest-based Circular Bioeconomy", the event aimed to disseminate new forest products and technologies from all Higher Education Institutions, Science and Technology Parks, and Technological Interface Centers in the Central Region, due to the great potential of the region. "Models and Strategies for Valuing Knowledge" were analysed in an initiative that included interaction between companies, researchers and a think tank, functioning as a moment of reflection and literacy on the future of the circular forest-based bio-economy.












### ix. Approved projects: UCILeR colaborates with a project granted by PRR

The minimum budget is 50,000.00€.

vii. FMSH mobility programme for advanced teachers and researchers - Social Sciences and Humanities - France - 2023



The Fondation Maison des Sciences de l'Homme (FMSH) will finance work visits to France (4-6 weeks) for field studies, bibliographic research and archival work. Eligible candidates are professors and researchers in a medium or advanced career stage, with a PhD (or equivalent), and working in higher education and research institutions outside France.

Applicants must be under 65 years of age at the time of their visit. Priority is given to projects that require fieldwork (surveys, work in libraries or archives, etc.) in France. Any request for the sole purpose of writing an article or a book will not be considered. The funding consists of a monthly allowance of 3,400 euros that is granted to support travel and subsistence expenses. In addition, FMSH provides logistical support, such as assistance with visa applications.




