I. Latest UCILeR events



OPEN CLASS "LOCAL LODGING: COMPARATIVE ANALYSIS OF URBANISTIC, REGULATORY AND TAX ASPECTS"

On November 7, an open class/roundtable discussion was held on "Local Lodging: comparative analysis of urban planning, regulatory and tax aspects" in room 9 of the Law Faculty of the University of Coimbra. Professors Fernanda Paula Oliveira (FDUC) and Carmem Ávila Rodriguez (Law School of the University of Málaga) discussed urban planning and its regulatory aspects. The tax aspects were addressed by Professors Suzana Tavares da Silva (FDUC), Nora Rodríguez Peña (Faculty of Law of the University of Salamanca and Marta Costa Santos (FDUC).



NEW DEVELOPMENTS IN DAMAGE INSURANCE" SEMINAR

This hybrid event was held in the Chapel of Trinity College on November 11. The theme of damage insurance was addressed from various perspectives, including compulsory automotive liability insurance, insurance and incoterms 2020, insurance and condominiums, and professional liability insurance, among other topics.



COLLOQUIUM/WORKSHOP "MIGRATIONS, HUMAN RIGHTS AND CITIZENSHIP"

This event, held on November 17, included papers by invited speakers and speakers who responded to the call for papers. The event discussed the implications of and solutions related to the impact of migration in different contexts of citizenship in today's complex and heterogeneous societies. Aligned with the UN Sustainable Development Goals (SDGs), the seminar addressed notions related to the essential conditions for sustainable coexistence and livelihood. The scientific committee comprised Professors Ana Margarida Gaudêncio (UCILeR/FDUC) and Clara Cruz Santos (Lusíada Center for Social Service Research - CLISSIS - Lusíada University; Observatory for Citizenship and Social Intervention - Faculty of Psychology of the University of Coimbra - OCIS- FPCEUC).



CONFERENCE "CAN SCIENCE WITH ETHICS SAVE THE WORLD?"

This conference was held between November 21st and 24th in a hybrid format, from the Palácio dos Melos. The debates centred around the role, methods, and ethical limits of science and technology diplomacy in its broadest sense. The scientific coordination of the event was under the responsibility of Professors Alexandra Aragão, Isabel Freitas Valente and Philippe Billet.





IV JUSTSIDE CONGRESS

The hybrid event was held on November 29th and 30th from the Law School of Coimbra University. The debates on the opportunities, successes and challenges of territorial justice for sustainable development included speakers from Portugal, Brazil, Cuba, Chile, Costa Rica, Colombia, Mexico, Uruguay, Argentina and Spain.


V DEBATE FORESTS AND LEGISLATION: FIRES, ENVIRONMENTAL PROTECTION AND CLIMATE CHANGE



I. Internal life of the UCILeR

i. Participation of UCILeR researcher in the 2nd edition of Inovação@UC



Professor Dulce Lopes, an UCILeR integrated researcher, addressed the law's responses to societal challenges during the 2nd edition of Inovação@UC, having presented the main activities of scientific dissemination and extension that have been carried out by the UCILeR.

ii. Dynamic activity: Is there an escape from Open Science?



The dynamic activity on Open Science that took place on November 24 at Trindade College is part of the Science and Technology Week 2022, Ciência Viva programme. Through the escape room game "Is there an Open Science escape?", the participants were transported to a future scenario where all research is published in diamond access, that is, without costs for readers or authors.

iii. Right to My City Project



The project World Cities Day: Right to my City, that was launched on September 30 with the aim of discussing the theme of the cities of the future - more sustainable, inclusive and conserving of their heritage - with teachers of the 3rd cycle of basic education and high school, held a series of activities in November and December. The Conversations at School took place on November 15 at Dom Duarte Secondary School ("What rights in the city?", by Professor Fernanda Paula Oliveira); on November 16 at José Falcão Secondary School ("The school as a city", with the participation of Professors Gonçalo Canto Moniz and Carolina Coelho), and on November 21 at Quinta das Flores Secondary School ("The University of the City and UNESCO", by Professor Milton Pacheco). On December 7, the contest "Right to my city" was also launched, under the scope of the "World Day of Cities - Right to Citizenship and Culture" project, with registrations open until December 31.

iv. Celebration of the International Anti-Corruption Day on December 9



To mark the date, the UCILeR shared the publication of the book "Corruption and Human Rights. A Transatlantic Dialogue", organized by UCILeR researchers Professor Jónatas Machado and Eduardo Figueiredo, which includes articles written by several other UCILeR researchers, as well as experts on the subject in Brazil and Portugal.

v. Celebration of International Human Rights Day on December 10



With the slogan "Dignity, Freedom, and Justice for all," the UCILeR made and posted on the social networks two videos intended to mark the anniversary and reflect on the importance of human rights.

vi. Submission of national or international projects



The UCILeR collaborated in the submission of three international applications last November. In partnership with other UC researchers, led by Proaction Lab, the UCILeR team, composed of Anabela Miranda Rodrigues, Susana Aires de Sousa and

Fernando Borges, contributed to research tasks on the ethical and legal implications of the relationship between people and robots through artificial intelligence systems and project implementation and communication tasks. From this partnership emerged two applications for funding in Cluster 4 of Horizon Europe: TRUSTYCOBOTS - Trustworthy human-robot collaboration through human-machine interfaces and NEUROCOBOTS - Developing brain-machine interface for dynamic human-robot collaboration.



Driving Urban Transitions

Led by the University of Lucerne, the application PERSIST - Positive Energy diStrictS driven by ciTizens has been submitted to the first phase of DUT funding (Driving Urban Transitions). DUT funding partnerships aim to contribute significantly to the global mission on climate neutral cities, the European Green Deal, and the Urban Agenda for the EU by developing and implementing a transformative research and innovation (R&I) programme. The UCILeR team led by Professor Fernanda Paula Oliveira was responsible for the analysis of the current legislation on the creation of energy communities and the implementation of a living lab in Portugal.



Professor Alexandra Aragão, UCILeR integrated researcher, is part of the ALICE project team - Air pollution: a stressor for environmental justice approved by FCT in the call for projects in all scientific fields 2022. The project is coordinated by the University of Aveiro and will address air pollution as a problem of great environmental and health risk. Outdoor air pollution is responsible for 4.2 million deaths worldwide every year. However, pollution affects each person differently, depending on their age and physical condition, but also their socioeconomic status, which influences their ability to cope with this problem. Governments must promote justice, and while legislation is based on these principles of justice, its implementation can have a disproportionate impact on vulnerable and marginalized communities due to startling socioeconomic inequalities. This understanding has led to the emergence of the concept of Environmental Justice, which aims to address these inequalities by establishing links between environmental issues (such as air pollution), social and economic determinants, and habitual location (place of residence, work or leisure) in order to assess the equity of these relationships and identify points of territorial injustice. The project is scheduled to begin in March 2023.

Environmental Building Passport: Electronic Land Registry's Contribution to the Ecological Transition

The event will take place in hybrid form between 9:30 am and 5:30 pm from Trinity College. The climate and environmental crisis, formally declared in 39 countries, forces us to think about new legal models for the energy and ecological transition. In addition to prohibitions and authorizations, planning and incentives, emission permits and green bonds, land registration may be a key legal instrument in the intended transformation. The consideration of environmental and climate aspects reinforces the prominence given to the reality of the building in the land register, giving visibility to the contributions, positive or negative, of each property to the state of the environment and climate at local, national, and global levels. The new environmental and climate functions of the land registry will influence the real estate legal trade through the knowledge of the ecological value of the building, making transactions more transparent and public policies more responsible.


ii. 18th World Consumer Law Conference of the International Association of Consumer Law (IACL)
