
- Edition of a periodical in English, with annual periodicity (Undecidabilities and the Law: The Coimbra Journal for Legal Studies);

These Scholarships are intended for candidates enrolled or that satisfy the conditions for enrolment in study cycles leading to a PhD degree. The work program may occur partially or integrally in a National Institution (scholarship in Portugal or mixed scholarship) or in full in a foreign institution (Scholarship abroad). In the case of mixed scholarships the period of the work program in a foreign University cannot exceed two years. The duration of the scholarships is generally of a year, renewable until the maximum number of months indicated in the application, and cannot be conceded for a period lower than 3 consecutive months or higher than 48 months. **Call ends 31 March 2020.**
