This seminary, which brings together, in felicitous convergence, all the research areas of our Institute, actually began on October 8th (with a precious intervention by Professor Fernando Bronze) and will continue without interruption until 17th December (with a no less promising final session, about which we will say something more below).


It is not just a matter of paying attention to Seminário Geral, but of pointing out its new leading theme, focused on the "societal challenge" of artificial intelligence (one of the thematic cores that UCILeR's research has been giving precedence to). After a sequence of nine sessions, covering all fields of Law, and involving fifteen of UCILER's integrated researchers, distributed over several modules (see details at https://www.uc.pt/fduc/cursogeraldoutoramento/ PDFS/2021-2022-SeminarioGeral.pdf), the final session will benefit from a wider audience, involving not only PhD students but also the general public. Bringing together Professors Anabela Rodrigues and Christoph Burchard (Professor at the Goethe Universität Frankfurt am Main and principal investigator in the excellence cluster "Die Herausbildung normativer Ordnungen"), this final session (December 17th) promises to be a major conversation piece (truly one not to be missed!) focused on the possibilities, challenges and problems that our time of artificial intelligence imposes on Law in general and Criminal Law in particular.

#### **II IBERO-AMERICAN MEETING OF DOCTORAL STUDENTS OF PROCEDURAL LAW**

The UCILeR, in partnership with the University of Salamanca, organised the II Ibero-American Meeting of PhD students of Procedural Law, which took place in Coimbra. The event was held in a hybrid format, free of charge. Doctor Maria José Capelo, from the University of Coimbra, and Doctor Lorenzo Bujosa-Vadell, from the University of Salamanca were in charge of the scientific coordination of the event.





## I. UCILeR's Internal life

**i.** The UCILER was present at European Researchers' Night 2021, at the Palace of Justice. In this edition of European Researchers' Night, about 300 researchers, professors and doctoral students shared with the non-academic public the scientific research they develop at the University of Coimbra, on a Science Route that included 45 locations, from Coimbra's Upper Town to its Lower Town. This year, the initiative, coordinated by the Institute for Interdisciplinary Research, had a programme with dozens of activities (experiments, demonstrations, hands-on activities, guided tours, challenges, quizzes, concerts, speed dating, conversations on the bus), many of them in close collaboration with several institutions of the city of Coimbra.

**ii.** The article "Mitigating the Covid-19 Pandemic: A Portrait of the Experience from the Lusophone World" was published in the Medicine and Law Journal. Collectively authored, the article summarizes the project "Public Health Responsibility in the Lusophone World: Doing Justice During and Beyond the COVID Emergency" financed by the WHO, led by Doctor André Dias Pereira, the main author of the article.

**iii.** From 20 to 23 September, the 1st Meeting and Practical School of the "Global Digital Human Rights Network" took place at the Holy Trinity College of the Faculty of Law of the University of Coimbra. This meeting, which took place in a hybrid format, was attended by more than 30 participants from all over Europe, in addition to those who participate remotely via Zoom. This meeting is part of the Global Digital Human Rights Network, a COST Action, of which the UCILER is one of the members, through its researchers Alexandre Dias Pereira and Paula Veiga. The Global Human Rights Network explores the theoretical and practical challenges imposed by the digital and online context in the protection of Human Rights.

**iv.** On September 29th, a webinar entitled "Future Fire Scenarios and Biodiversity" took place. It was promoted by the firEUrisk Project, an EU-funded research project, led by ADAI and with the participation of the UCILeR. The project "FirEUrisk - Developing a holistic, risk-wise strategy for European wildfire management" was approved under the European Union's Horizon 2020 program, bringing together in consortium 39 partners from around the world (Germany, Australia, Belgium, Canada, Cyprus, Spain, United States of America, France, Finland, Greece, Netherlands, Hungary, Israel, Italy, Portugal, United Kingdom, Romania, Sweden, Ukraine), and involving a team from the UCILeR.

**v.** The webpage of the "Evacuate Forest" project was launched. The project is intended to contribute to the decision making and development of evacuation plans in forest fire scenarios, aiming to build a decision support system directed at the protection of the vulnerable population at risk. Evacuate Forest is a project of the UCILeR and is funded by the Foundation for Science and Technology under the Projects of Scientific Research and Technological Development Within the Scope of Preventing and Fighting Forest Fires.

**vi.** On 20 October, the launch of the book "New Directions for Environmental Law: A Look at Geodiversity", co-organised by Alexandra Aragão, UCILeR's researcher, took place. The book launch event was attended by the other two book organisers, Luciana Cordeiro de Souza-Fernandes, and Artur Agostinho de Abreu e Sá. The work is innovative in that it offers the reader several perspectives on the environmental theme, uniting Law and Earth Sciences and offering the bases for the multi-, inter- and trans-disciplinarity necessary for the enforcement of environmental legislation. The book comprises a set of twenty-four chapters by renowned authors, professors and members of Portuguese and international research groups, including some UCILeR researchers.

**vii.** The project "MediMARE, Mediation in Maritime Disputes" was awarded first place in the EEA Grants - Blue Growth Programme #5. The project will be led by UCILeR's researchers Maria José Capelo and Dulce Lopes and has Portuguese, Norwegian and Swedish partners. The goal of the project is to develop courses and training tools to help students and professionals to introduce mediation in their skills and promote an environment and culture of peaceful and equitable resolution of conflicts in maritime issues.

#### ii. Francisco Manuel dos Santos Foundation Studies

The Francisco Manuel dos Santos Foundation (FFMS) was created in 2009 with the statutory mission of promoting and deepening knowledge of the current state of affairs in Portugal. With this in mind, an area of studies was created which, since 2012, has published more than five dozen academic studies in the areas of Economics, Institutions and Society.

The priority themes to be explored in the projects awarded by the Foundation are defined in advance by its Governing Bodies and published in the triennial Study Programme. The authors of the Foundation's studies, generally academics linked to universities and national and international research centres, are selected through a public and transparent application process, in order to guarantee the rigour and independence of the research produced.

The application process for the preparation of studies promoted by the Francisco Manuel dos Santos Foundation is permanently open during the current Study Program (2021-2023).
