# "LAW AND TIME" - VII MEETING OF DOCTORAL STUDENTS

The tradition of doctoral researcher meetings in the area of "Law and Time" continued (in webinar format), this time with an opening conference that brought to us Professor Saulo Matos, Adjunct Professor at the Federal University of Pará, who holds a Master's Degree in Law from the Ruprecht-Karls-Univesität of Heidelberg and a Doctorate in Social Philosophy and Philosophy of Law from the Georg-August-Universität of Göttingen. The title of the communication was: "Ideal or non-ideal justice? John Rawls' ideal theory argument revisited in honour of his centenary".

# I. UCILeR's Internal Life

**i.** The UCILeR, through its researchers, was present at the Conference "The Rule of Law in Europe", held on 17 and 18 May, in a hybrid format. In this event, held within the scope of the Portuguese Presidency of the Council of the European Union, communications were presented, on the 17th May, by Dulce Lopes (*The role of civil society for upholding the rule of law*), Pedro Caeiro (*The role of European and national courts for upholding the rule of law*), José Manuel Quelhas (*The role of European and national courts for upholding the rule of law*), Alexandre Soveral Martins (*Communicating the rule of law*) and Ana Gaudêncio (*The rule of law under the Lisbon Treaty*), and, on the 18<sup>th</sup> of May, by André Dias Pereira (*The rule of law in the context of the COVID-19 pandemic*), Joana Vicente (*Rule of law, social progress and economic recovery*) and José Casalta Nabais (*Rule of law, social progress and economic recovery*).

ii. A new research project called FirEUrisk has received €10 million from the European Union for integrated forest fire management. FirEUrisk will develop over the next 4 years a science-based strategy to manage forest fires in Europe. The project involves 38 partners from all over the world, including universities, research centres and companies, who will collaborate with citizens, operators and policy makers. The resulting strategy will be tested in different pilot and demonstration zones throughout Europe. The UCILeR is one of the project's partners and will be represented by researchers Dulce Lopes, Alexandra Aragão and Inês de Oliveira Martins. The multidisciplinary team, which includes researchers, operators, doctors, lawmakers, and citizens, will study the vulnerability and resilience of communities and countries to forest fires, including the impact of fuel management policies and how the socioeconomic context and human activities influence vulnerability. FirEUrisk proposes to develop a new approach that will include innovative technologies, tools, training materials, regulations and policy recommendations that improve forest fire management and lessen the most devastating effects of forest fires.

**iii.** On 22 May the first Online Introductory Session of the ECI: from A to Z project took place. Students were welcomed, working groups were formed and, above all, experiences and hopes were shared. The main goal of the Project is to promote civic engagement and voluntary participation of higher education students in public life on a community scale, allowing them to build and launch their own citizenship initiative from a markedly collaborative, practical, and dynamic approach. The project includes the participation of partners from Germany (University of Göttingen), Spain (University of Vigo) and Romania (University of Iasi). In Coimbra, the team is led by Dulce Lopes and has the participation of researchers from the UCILeR (Alexandra Aragão, Fernando Borges, Eduardo Figueiredo and Rita Aroso Duarte) and the University of Coimbra's Distance Learning project (UC\_D).

**iv.** On May 24, another session of the cycle of "Conversations on Research and Science at the College of Trindade" took place, still in online format. The session aimed to give clarity the researchers about the support and funding available within the University of Coimbra. Representatives from the Strategic Areas of the UC, the Division of Support to Research Projects and the Division of Projects and Activities were present. The Conversation began with a presentation of the Horizon Europe Programme and other European funding. This was followed by an exposition on the support provided by the Strategic Areas of the UC in the preparation of applications, as well as the support provided by the Division of Support to Research Projects and the Division of Projects and Activities in the subsequent execution of the projects.

**v. T**he UCILeR is part of two consortiums in applications for the Erasmus + program. As proponent, the UCILeR led the application "Guides for inclusion: diversity and responsibility in sports journalism education" under the "Partnerships for Cooperation - Higher Education Sector" which includes the participation of researchers Fernando Borges and Dulce Lopes, as well as the collaboration of the distance learning area of the University of Coimbra. In the role of partner entity, together with researchers from the Faculty of Sports Science and Physical Education, researcher Fernando Borges integrates the project "European Holistic University Sport Club" led by the National Union of University Clubs of France.

# II. Calls for papers

# i. Undecidabilities and Law

Undecidabilities and Law's second volume welcomes contributions that highlight the modes of interpretation of values, interests and rights in situations where cultural conflicts arise. We are interested in articles that showcase the forms by which international and national Courts as well as other legal operators, such as the legislature and the administration (for instance during the recent pandemic), deal with structural or intensive diversity of legal rules, principles, and values.

All areas of legal research are welcome, from those which reinvent traditional human rights issues in national and international settings, through those which reconstitute the exacerbated cultural conflicts of our times, to those which consider discrimination and the failure to recognize diversity, and those which explore the contrast between freedom of trade and export restrictions, for instance in situations of trade embargoes, or the export (and restitution) of nationally valuable works of art.

# iv. The European Social Charter Turns 60: Advancing Economic and Social Rights across Jurisdictions

The European Social Charter overlaps and interacts with a series of national, supranational, and international legal sources for the protection of economic and social rights. Within this pluralistic legal framework, the role of each instrument has evolved from both a substantive and procedural perspective. On the one hand, the protection of economic and social rights in Europe occurs as a result of the systemic interpretation, harmonisation or integration of the substantive guarantees set out in national constitutions, the EU Charter of Fundamental Rights, the European Convention on Human Rights, and other treaties such as the International Covenant on Economic, Social and Cultural Rights and ILO Conventions. On the other hand, such protection is reinforced through the activation and concomitant interaction of various enforcement mechanisms, namely national courts, supranational and international courts, and other treaty bodies. Only through a systemic and cross-sectoral framework can the effectiveness of the European Social Charter be fruitfully assessed, both in theory and in practice, which makes the benefits of a multidisciplinary and interdisciplinary analysis such as the one sought to be undertaken through the conference and subsequent publication organised by the University of Turin.

Innovation and Sustainability are the motto of the Fraunhofer Portugal Challenge 2021. The aim of this competition is to distinguish the best research work of practical utility developed in Portugal. It is an ideas competition organized annually by the Fraunhofer Portugal association and is aimed at students and researchers from all Portuguese universities. The ideas in the competition should have a practical side, be market-orientated, with applicability in industry or in people's daily lives. The best ideas that embrace technology-based ideas and focus on sustainable solutions for the most pressing challenges in the areas of production and industry, agriculture, natural resource management or the promotion of well-being will be awarded. The competition involves two categories, Master's and Doctoral, with three finalists in each category (six in total) being awarded.
